Letter from the Chair:

The UGSG is involved in a number of interesting events that will take place at the AAGs in Chicago. Along with the journal *Urban Geography*, we are co-hosting Jamie Peck's plenary talk, "Liberating the City: Between New York and New Orleans." His paper will develop an analysis of the "new urban right" and its narration of urban crisis in mid 70s New York and post-Katrina New Orleans. That talk is on Thursday from 5-6:40 and will be introduced by Bob Lake and Elvin Wyly and discussed by Laura Liu and myself. We are also co-sponsoring a talk by Cindi Katz entitled, "Chicken Money Job Water: Katrina and the Scoured Landscape of Social Reproduction." As is evident from the titles of these two talks, the rebuilding of New Orleans in a neoliberal mode is foremost in many urban geographers minds. Katz's talk is on Friday at noon. A third plenary session we are co-sponsoring is one by Dennis Judd on Thursday at 3:00. This talk is "Tracing the Commodity Chain of Global Tourism." In it he will examine the ways that tourism is a manufactured product and not just a consumption activity and as such should be considered within the broader economic and urban literatures. Our final co-sponsored plenary is an author meets critics session on Retort's "Afflicted Powers: Capital and Spectacle in a New Age of War." That will be held in a double session on Thursday morning beginning at 8:00.

In addition to this wealth of plenary sessions we are also co-sponsoring sixty-three panels on urban related themes! These are listed in this Newsletter on pages 7-21, or you can find them online by typing in 'urban geography' after pressing the specialty group button on the AAG's preliminary program on the web.

Other UGSG events include a party at Miller's pub on Wednesday evening from 5:30-6:45 where we will provide the appetizers. Many thanks to Jim Fraser for putting this together. Following the party go directly to the UGSG board meeting, which will be held at the same

Position Announcement

Editor of *The Geographical Review*

The American Geographical Society invites applications and nominations for the position of Editor of *The Geographical Review*, the longest-running geography journal in America. The new editor will begin work in June 2006 with responsibility for producing three volumes.

The AGS provides an honorarium for the Editor per issue. It provides the services of a copy editor/production assistant. Modest funds are also available to defray expenses in conjunction with the performance of editorial tasks (telephone, postage, travel, etc.) However, the contributions of each applicant's home institution toward such expenses will add weight to the candidate's application. To deal with authors promptly and keep the journal on schedule, it is essential that an applicant be able to secure office space at his or her home institution as well as at least one-quarter released time from normal duties and the help of a university-supported editorial assistant, preferably half-time, year-round.

The Editor determines the content and overall format of the journal; encourages the submission of high-quality, well written manuscripts on geographical issues and problems; decides which books should be reviewed in the journal and who should write those book reviews. If the Editor wishes to do so, responsibility for the book review section may be delegated to someone of the Editor's choosing. The Editor is assisted by an Editorial Advisory Board that is composed of individuals selected by the Editor.

The American Geographical Society is seeking an editor who (1) has a broad perspective on the discipline of geography and a well-developed understanding of both the discipline's history and current research priorities; (2) has an excellent command of written American English; (3) is familiar and comfortable with the types of word-processing and graphics programs commonly used in digital publishing; (4) possesses strong organizational skills and the ability to work quickly and juggle multiple tasks; (5) has the ability and willingness to work with authors to ensure that articles in *The Geographical Review* deal with important geographical issues in a clear, accessible style; (6) has an understanding of the nature and mission of *The Geographical Review* and the American Geographical Society; (7) has the desire and ability to explain the AGS vision for *The Geographical Review* to others and to encourage the submission of manuscripts in keeping with that vision; and (8) has a record of scholarly accomplishment and publishing.

To ensure an orderly transition, the selection of an editor will be made by May 31, 2006. Names of nominees and letter of application should be sent to the Chair of *The Geographical Review* Search Committee, Deborah E. Popper, c/o The American Geographical Society, 120 Wall Street, Suite 100, New York, New York 10005-3904. Letters of application should include a statement of the applicant's understanding of the goals and mission of *The Geographical Review*, an explanation of the applicant's approach to the performance of editorial duties, and a description of any relevant background or experience. The application should be accompanied by 1) a current curriculum vitae, 2) the names of three individuals who can be contacted for references, and 3) an indication of the office space, released time, editorial assistant, and any other support offered by the applicant's home institution. A written confirmation from the university of the support to be provided will be required before the American Geographical Society makes a commitment to the applicant selected.

INTRODUCING THE NEW BOARD MEMBERS 2006 – 2008:

- **Dr. James DeFilippis** is an Assistant Professor in the Department of Black and Hispanic Studies at Baruch College, City University of New York (CUNY). Dr. DeFilippis received his Ph.D. in geography from Rutgers University in December 1999. He then worked as a Lecturer in the Department of Geography at King's College London. He returned home to New York in the summer of 2002 and worked as a Housing Policy Analyst at the Community Service Society of New York before going to Baruch. His research can be broadly described as urban political economy, and he has focused on issues of community development, local economic development, affordable housing policies, urban politics, urban social movements, and social capital.

Dr. DeFilippis is the author of the book *Unmaking Goliath: Community Control in the Face of Global Capital* (Routledge Press, 2004), which was recently named by the American Political Science Association as the best book on urban politics in 2004. He has also published many articles and reports on housing, community development, urban politics, and local economic development. He is the editor of the Interventions and Reviews sections of *Antipode* and the North American editor of *Local Economy*.

He is currently working on several books, including: *Community Development: The Reader* (with Susan Saegert); *It Takes Much More Than A Village: The Potential and Limits of Community* (with Robert Fisher and Eric Shragge); and *Is Community Possible?* (with Randy Stoecker). He is also engaged in a long term research project with colleagues at the Brennan Center for Justice (at New York University School of Law), the University of Illinois at Chicago, and the University of Wisconsin, Madison on unregulated labor in New York City and Chicago.

- **Kate Boyer** is currently employed as a Clinical Assistant Professor in the Department of Science and Technology Studies at Rensselaer Polytechnic Institute in Troy, New York. Her research cuts across fields of Urban Social Geography, Feminist Geography, and Urban Policy, and is principally interested in questions of work, urban culture and social justice. She received her Ph.D. in Geography from McGill University in 2001, where her dissertation focused on the role of the feminization of clerical work in advancing conceptions of modern womanhood that were consummately urban in nature. Her post-doctoral research brings her interests in gender, space and power into a more contemporary and policy-oriented realm, focusing on the intersection of information technology, social policy and urban politics in the contemporary U.S. In this vein she is particularly interested in the way IT shapes interpretations of welfare reform, and the new political mobilizations of low-income advocacy and activist groups challenging neoliberal social policy offensives. Before her present position she worked as an analyst at a public policy think-tank studying welfare reform between 2000 and 2002, and before that she served as a Visiting Assistant Professor of Urban Studies in the department of Geography and Planning at SUNY-Albany between 1998-2000. She has been active in the AAG and CAG since 1992, and has served as a board member of Geographic Perspectives on Women and Qualitative Geography Specialty Group. She brings something of a policy and an interdisciplinary perspective to her role as board member.

- **Caitlin Cahill** is an assistant professor of Community Studies at the University of Utah. She received her doctorate in Environmental Psychology with a concentration in Public Policy and Urban Studies from the City University of New York, Graduate Center. Caitlin's research interests include young people's well-being, racial equity, community development, critical race and feminist theory, and participatory action research approaches. Caitlin's doctoral research focused on the relationship between young working class women of color's identity development, representations, and urban development. At the center of her study was a participatory project entitled "Makes Me Mad: Stereotypes of Young Urban Womyn of Color" (www.fed-up-honeys.org). Currently she is developing a parallel project, "Growing up in Salt Lake City" which will consider how global economic urban restructuring is experienced by young people here. In addition Caitlin has just started a new collaborative study of community concerns and civic engagement in low-income communities in Salt Lake City. At the upcoming AAG, Caitlin co-organized three sessions on "The Politics of Participation" with Rachel Pain, and another with Cindi Katz, "The young Americans: Children's and youth geographies in the USA." In addition, Caitlin is an editor for the journal *Children, Youth, and Environments* (www.colorado.edu/journals/cye).

- **Stephanie Campbell** is a Ph.D. candidate in the Department of Geography, Simon Fraser University, British Columbia, Canada. She received her B.S. in Geography at The Pennsylvania State University in 2002 and her M.A. in Geography at The Ohio State University in 2004. Her Master's research focused on the simultaneous, and paradoxical, concealment and exposure of homeless people in downtown redevelopment efforts in Columbus, Ohio. Stephanie is currently examining discourses of community, economic development and mobility in Vancouver, British Columbia. She plans to specifically address neighborhood activism surrounding urban policies and transportation decision-making. Her broader interests involve: the politics of urban development and policy-making;

power geographies; and the role of place, space, and scale in these areas. Stephanie is an active member in the GeoSpeaker Colloquium Committee, the Graduate Studies Committee and the Geography Graduate Association at Simon Fraser. Since joining the AAG in 2002, she has been a member of the UGSG.

- **Jim Fraser** is currently an Associate Research Professor in the Department of Geography at the University of North Carolina (UNC-CH). He also holds an appointment as a Senior Research Associate at the Center for Urban and Regional Studies at UNC-CH. His focus in urban geography has been around neighborhood/downtown revitalization and how these efforts intersect with poverty policy. Some of my particular interests have been: (1) how discourses around globalization and economic restructuring are mobilized to justify spatial investment patterns; (2) the socio-spatial identity work that shapes neighborhood change (who has rights to claim neighborhood space); (3) the roles of state-market-society sectors in the context of neoliberal urban policy initiatives; (4) the reproduction social inequality (examining, in particular issues around race, class, and gender); and, (5) how urban redevelopment public policy has a transnational dimension affecting immigrants. In addition to these efforts he also studies cities and flooding disasters. This work has been funded by multiple foundations and government agencies and has produced reports accessible on his web site (<http://www.unc.edu/~fraser18/>) as well as publications in journals including Urban Geography, Urban Affairs Review, Urban Studies, Community Development Journal, Journal of Poverty, Space and Culture, and City and Community.
- **Russell M. Smith, AICP, MPA** For the past 2 years I have been pursuing a Doctor of Philosophy degree in Geography at the University of North Carolina at Greensboro. My concentration within the Geography Department is in Urban and Regional Economic Development and Planning. I have focused my research on examining the development of new municipalities around growing metropolitan areas and other urban planning issues. In addition to pursuing my Ph.D., I have taught several courses at UNC-G and surrounding universities. At UNC-Greensboro I have taught undergraduate courses including: Introduction to Geographic Information Science, Urban Planning: World Patterns, and Urban Planning: Land Use. I also taught two courses at Elon University (NC). Prior to returning to school to work on my Ph.D. at UNC-Greensboro, I was employed for eight years as a planner for various governments in North Carolina. My work experience includes being the Assistant Planning Director for a city of 50,000, working as a Regional Planner for the State of North Carolina and being employed as the first City Planner in a small town of 15,000 people. During my time as an urban planner I was exposed to many issues that confront urban geographers including sprawl, downtown revitalization, and economic development.


